I'll also be working with national and our state board of directors to develop leadership training. Meanwhile, I encourage branches to check out resources on the national web site (<u>http://www.aauw.org/resources/</u>). It's a treasure trove of information.

We have a lot to do, but we have a core of dedicated women that I hope to see grow over the next few months, at both state and branch levels. # The 2014 Project

In conjunction with The 2014 Project Alabama, AAUW of Alabama's Ready to Run<sup>™</sup> political training program was held in Jacksonville, Saturday, September 21. Twenty-five participants attended. Ready to Run is a nonpartisan program for women who want to run for office, work on a campaign, get appointed to office, become community leaders, or learn more about the political system. It is affiliated with Rutgers University Center for American Women and Politics. The 2014 Project Alabama is a statewide, nonpartisan campaign to increase the number of women in government leadership.

## **Greetings Branch Finance Officers!**

I am providing you information here to show you how your responsibilities as a finance officer can be **simplified**. There is a more efficient way of paying dues.

Imagine **never** again writing checks for national and state dues and limiting postage spent. How would you like to receive monthly **automatic** payments to your branch bank account as payments are received at the national level? That is exciting!

You can accomplish this simplification by participation in the **Membership Payment Program** (**MPP**), which is located within AAUW's Member Services Database (MSD) found at the bottom of AAUW's home page *www.AAUW.org.* FYI, AAUW of Alabama already participates in the MPP.

Briefly, the MPP is a secure, convenient, and free online membership processing alternative through centralized dues processing. Once enrolled in the MPP, you enter membership checks online through the MPP, remitting the entire membership dues payment (national, state, and branch). Then, you submit the dues report online and print out two dues reports, one for your records and the other to mail to AAUW Membership in Washington, DC along with the checks processed. The address is on the dues report. Dues reports are available online also for easy follow-up.

Accepting, entering and mailing checks could be altogether avoided if members renewed their memberships online by choosing "renew my membership" located under MPP and making payment via credit card/debit card. Then, AAUW National would automatically auto deposit dues paid to state and individual branch accounts once per month around the  $23^{rd}$  of each month.

**STEP 1** Complete the **MPP Opt In** online application form. It will request information on your bank, account number, Tax ID number, and branch dues.

**STEP 2** Allow 10-14 business days for your branch banking information to be tested and verified to ensure successful deposits to your account.

**STEP 3** Branch and state finance officers will receive an email when you are approved to begin use of the MPP system.

Please contact me if I can help you with the process of setting up MPP access.

## AAUW of Alabama's State Organizer Grant and AAUW Public Policy Issues

AAUW of Alabama has received a State Organizer Grant from AAUW to increase membership, to pursue college and university partners, to recruit e-student affiliates and to develop coalitions with other state organizations on common public policy goals.

As AAUW of Alabama Public Policy Chair, I'm working with Chardonnay Singleton, State Organizer, from Tampa, Florida, to launch the program. Committee members from AAUW branches throughout the state have been recruited to join in this effort: Wanda Foster (Huntsville), Jo Ann Cummings (Decatur), Audrey Salgado (Birmingham), Lee Ann Webb (Montevallo), Nancy Wilstach (Montevallo), Susan Barrow (Birmingham), Leevones Fisher (Mobile), and Joan Hudiburg (Shoals). Representatives from Marion and Scottsboro Branches have been invited. Also joining this effort is Lilly Ledbetter, who will serve as Honorary Co-Chair of the committee. Committee members have been appointed to geographically represent the state and/or because of their particular expertise. On October 3, committee members had a productive phone conference to firm up plans.

On Thursday, October 24, the AAUW of Alabama Public Policy Committee launched this State Organizer Grant program at a Montevallo Branch meeting at the Carmichael Library, on the University of Montevallo campus. I moderated the event, which brought together Chardonnay as keynote speaker, as well as other committee members: Wanda Foster, AAUW of Alabama President; Dr. Elizabeth Hendrix, national AAUW Public Policy Committee member; Nancy Wilstach, retired journalist, and Lea Ann Webb, Medicaid specialist, to address the issues and discuss plans for achieving the goals of the State Organizer grant. The meeting was attended by members of various branches and was both inspirational and enlightening.

Pay equity is only one part of an ambitious program that the state public policy team is working out with our grassroots coordinator. By having Lilly Ledbetter join our team, we have a strong, recognizable voice to help us advocate this cause. She very graciously agreed to help and will lobby for pay equity. State Representative Laura Hall, who has worked so faithfully and so long to get a pay equity commission established, has agreed to pre-file the bill. Once that is done, sometime before the holidays, branch members will need to contact their legislators and ask them to sign on to the bill. We need as many cosponsors as possible.

# **Public Policy (continued)**

In addition to pay equity, we will concentrate on the invalidation of Section 5 of the Voting Rights Act of 1965 (the recent lawsuit, *Shelby County v. Holder*, originated in Alabama's Black Belt, battleground of the civil rights movement); Voter Photo ID; the Affordable Care Act and health care reform in Alabama; and the Alabama Accountability Act, which is supposed to give tax credits to families with children in failing public schools to offset the cost of tuition at private schools.

Besides Nancy Wilstach (Voting Rights), Lea Ann Webb (Affordable Care Act and health care reform in Alabama), and Wanda Foster (Pay Equity, Building Coalitions), the committee includes Jo Ann Cummings (College/ University Partners), Audrey Salgado and Susan Barrow (Membership), and Joan Hudiburg (New/Revitalized Branches). I will also work on the Alabama Accountability Act and Building Coalitions. The committee will work with appropriate state officers and our intent is to involve branch public policy chairs/ committees. By June 30, 2014, we want to have helped establish a strong public policy network throughout Alabama.

The purpose of this meeting is to provide information to the public, including details about how the Act is structured and how it is impacting the students, the schools and the Education Budget in the state. Among panelists are those from the local school board, the Alabama Education Association and local legislators.

This meeting is open to the public and will be held at the Decatur Public Utilities Auditorium at 1002 Central Parkway. Doors open at 6:00 PM and the event will start at 6:30 PM.

On January 16, our meeting will be about the Voter Photo ID and the possible disenfranchisement of voters who do not have the correct ID or documentation. This meeting will be held at Logan's Steakhouse, 2315 Beltline Rd., Decatur, at 5:30 PM for dinner, or 6:00 PM for the program.

## Montevallo Branch

In 2013-2014, the Montevallo Branch will sponsor programs which offer opportunities for learning more about ideas and issues that affect women and their families, and for working with others to promote equity, research, and education. Our branch theme is "Educational Opportunities for Lifelong Learning." We will focus on educational opportunities at all levels and in a variety of settings, voter education and voter registration.

Our Public Policy concerns include voting rights and access to affordable health care, and our October meeting was devoted to these topics. Voter registration and absentee ballot information was available at the September and October meetings.

In accordance with AAUW's commitment to lifelong learning, literacy will be a major focus during the year. The Montevallo Branch will support Reading Is Fundamental for children, and the Branch will also support the Adult Literacy programs of the Literacy Council of Shelby County. At a reception for new and returning members on September 26, we explored ways in which our members can become involved in such projects to promote literacy and voter participation in our area.

Other educational initiatives include AAUW's national scholarships and research programs, our local AAUW Book Scholarship of \$500 for a deserving entering freshman student, and the AAUW Hallie Farmer Legacy Scholarship, initiated in 2011 to provide financial assistance to a UM junior or senior who plans to study Social Sciences with an emphasis on Human Rights and Public and Human Services. Periodically, the Branch does host fundraisers to help support such programs. These will include a Holiday Reception and Bazaar, scheduled for December 5 and a springtime Luncheon, Style Show, and Silent Auction.

We are planning an exciting Black History Month program in February with African American Studies Professor Wilson Fallin as speaker and Kenny Dukes, a young African American minister and NAACP member, as respondent.

We also plan to continue the ¡Adelante! Book Group, which brings together people from different generations and backgrounds to discuss multicultural books of special interest to women and their families. Book selections for the Fall semester include *The Iguana Tree*  by Michel Stone (October 9), *And the Mountains Echoed* by Khaled Hosseini (November 13), and *Flight Behavior* by Barbara Kingsolver (December 11).

At our annual celebration of Alabama authors in April, Margaret Wrinkle will speak about her book *Wash*, which tells the story of a Revolutionary War soldier and his slave.

Dates and times of our programs and book group sessions are listed on the Branch website (<u>http://montevallo-al.aauw.net</u>). All of our programs and activities are open to the public, and we especially welcome our AAUW friends from across the state to join us for any of these events.

## **College/University Partner Recruitment Drive**

One of our main priorities for AAUW of Alabama is to increase our membership numbers, and two ways that we can do this are through re-establishment of dormant branches and expansion in the numbers of colleges to become C/U Partners with AAUW. When we recruit college partners, we not only reach students on campus but we also have the opportunity to engage and recruit staff and faculty into AAUW membership, as membersat-large, or as part of a local branch.

These two things are tied together, because many of the branches in the past were established in cities that had colleges nearby. These include Tuscaloosa, Auburn, Montgomery, Tuskegee, Jacksonville, Enterprise, Troy and Dothan. That is why, as part of the College/ University Partner recruitment program, we are targeting colleges in those towns to become members.

Currently AAUW has 13 C/U Partners in Alabama, and we are targeting an additional 23 schools throughout the state, including many in those cities. Because there are so many schools in their communities, the Huntsville and Birmingham branches have established committees in charge of recruiting schools in their area. For other regions, JoAnn Cummings, our acting C/U Partner Chair, is going on recruitment trips to meet with appropriate advisors on campus.

A complete packet full of information about all aspects of AAUW has been prepared for each existing and target college, and is used to assist in the recruitment effort.

## HEALTH CARE REFORM UPDATE

October 1, 2013 marked the beginning of a major component in the Affordable Care Act, **the Insurance Marketplace**, where many people will be able to enroll in health insurance policies. The Marketplace is designed to help those who are without insurance or whose private or job-based insurance is too expensive, if those people (in Alabama) have incomes between 100% and 400% of Federal poverty level.

Since Alabama's leadership declined to set up a stateoperated insurance exchange, our state has joined 33 other states in using the massive <u>www.Healthcare.gov</u> website as the place to get more information and enroll. But as everyone knows, the launch of this website has had major difficulties.

Currently, the Department of Health and Human Services is projecting that the website might not be fully functional until late November, so they are recommending an alternate strategy to get people enrolled. On the front page of the Healthcare.gov website there are two very useful links that will help you (or your family) preview the important information that you will need to make your decision about a health plan:

- "**Find out if you qualify for lower costs**" provides you with an estimate of any cost savings (tax credits) you may be eligible for on your premiums.

- "See plans and prices in your area" lets you see which health plans are available in your county and gives an estimate of premium cost differences between them.

After you have reviewed the information, and evaluated your budget and your medical needs, you can call the Marketplace (1-800-318-2596), talk with a "live" assistant, and sign-up for your health plan choice by phone.

As noted in our last issue, Alabama leadership chose to not participate in **Medicaid Expansion**, which would provide Medicaid health coverage to all of those people below 138% of Federal poverty level. In Alabama, this represents about 300,000 low income people who are left without access to affordable health care. The state is also missing out on the infusion of federal funds that can cause up to \$20 billion in economic activity in the next seven years, and produce up to 31,000 jobs.

AAUW of Alabama has joined with others in a statewide "Medicaid Expansion Coalition" to develop strategies that might convince our state leadership to embrace the Affordable Care Act and expansion of Medicaid.



## **AAUW Huntsville Wins Tech Trek Grant**

As part of a continuation of AAUW's dedication to promoting STEM careers for women and girls, AAUW has initiated two pilot programs to introduce young girls

to careers in science, technology, engineering and math. These are **Tech Savvy**, a daylong STEM career conference for sixth through ninth grade girls and their families, and Tech Trek.

**Tech Trek** is a weeklong STEM summer camp for rising eighth grade girls. It is designed to develop girls' interest, excitement, and selfconfidence in STEM fields.



AAUW California began Tech Trek in 1998 with an AAUW Community Action Grant, and it has grown in California to 10 camps on eight college campuses across the state. Due to the success of the program, AAUW is bringing Tech Trek to three new states (Alabama, New Mexico, and Oregon).

AAUW of Alabama would like to congratulate the Huntsville Branch for being awarded a grant to establish our new location that will start the Tech Trek program for local middle school girls.
