AAUW Public Policy Impact Grant

Alabama is one of nine states to be awarded an AAUW Public Policy Impact Grant (PPIG) of nine hundred dollars for 2008-2009. We are well underway toward reaching our goals. One of the more ambitious proposals, our three-pronged project aims at: 1) Woman-to-Woman Voter Turnout, 2) a Pay Equity Education Program and 3) the Lobby Corps. Our activities in each area continue our purpose to achieve gender equality and economic security for women while we work closely with legislators to provide them with information and encourage their support for issues affecting women. Specific plans include: 1) Increasing the number of women voters by more than 10 percent in the targeted areas of Montevallo and Huntsville, 2) Educating more women in Alabama about pay inequalities and 3) Personally informing all our Alabama legislators in Washington and Montgomery on AAUW public policy priorities. These initiatives should boost AAUW membership in Alabama by 5 percent.

Our leaders in these ventures are: 1) Voter Turnout – Wanda Foster (Chair), Eleanor Davis, Fransia Foster and Laura Morgan; 2) Lobby Corps – Mary Jo Buff (Chair), Su Jin Jeong, Jennifer Delaney Rose and Audrey Salgado; 3) Pay Equity – Patricia Mason (Chair), Dr. Grace Jepkemboi and Jo Ann Cummings.

Among stated projects, some already completed and others on the calendar are: municipal candidate forums held in Decatur, Madison and Huntsville; a U.S. Congressional candidate forum in Florence on October 9; a Pay Equity conference at UABirmingham on **October 25**; voter registration pilot projects in Montevallo and Huntsville, the latter targeting drop-off voters with particular emphasis on lower-middle income women; workshops on each grant component during our state convention in Montgomery next April; publicity to promote Lobby Day and Equal Pay Day, also in Montgomery in April; recruiting at least 35 Lobby Corps volunteers over the next 5 years representing all Alabama House and Senate districts.

There are many ways all branches and all individual members can further these goals and assure our success well beyond the stated elements in our grant. All of us share in the challenge to make a positive difference for all women in Alabama. I encourage each branch to present these goals during at least one of your meetings and in your newsletters.

Place AAUW Public Policy as a standing item on your meeting agenda. Publicize your efforts locally and beyond. Please contact any of us for more information on the grant

and how you can participate. Thank you in advance for all your help. Please continue to keep us apprised of your stellar achievements toward fulfilling our goals!

President's Message

We are well on our way to another exciting year. This summer, AAUW of Alabama was awarded a Public Policy Impact Grant from National AAUW. With the election season upon us, we have already held several candidate forums with more planned. Other get-out-the-vote

activities will be held before General Election Day, November 4th. Throughout the rest of the year, more grant activities will occur, including starting an Alabama Lobby Corp, setting up a Pay Equity Day promotion and holding a salary negotiation seminar. In addition, we are continuing our Ready to Run programs throughout the state, to provide training to women interested in attaining leadership positions in government.

National AAUW supports efforts by the National Girls Collaborative Project to set up directories that list all of the programs in a region that help girls learn about STEM (Science, Technology, Engineering and Math) opportunities. But there is no NGCP program set up for Alabama yet. I am proposing that AAUW of Alabama act as a catalyst to bring together the appropriate colleges, organizations and businesses in a partnership to set up this project in Alabama. If you have a math, science or technology background, and would like to help or provide referrals, please contact me. Or, if you have the perfect contact or friend who would love to work on this, even if they are not an AAUW member, let me know.

AAUW has roots that are deep to support the education of women and girls, and to promote the attainment of advanced degrees by more women. But we are just not reaching enough women students and faculty on campuses in Alabama to help them meet the challenges they face.

I am looking for volunteers to strengthen our ties to women faculty and students on all of the Alabama college campuses. We need to reach out and find ways to inform more Alabama university women about the Education Foundation fellowships and grants, so that more Alabama women might get them. With the help of SAC students and student affiliates, we need to develop more programs that help solve the needs of women students on campus, while giving them leadership opportunities. While helping these women, we can find more friends and potential members. Together we will form a college relations team that works to provide the support we promised to our College/University partners. Please contact me to join this team.

We are continuing with our State website improvements. Soon we will have branch web pages prepared that are full of information on your branch's activities, and we will have branch officer training pages, which will extract important links from the National website that will be at your fingertips.

I hope that you will join us on our mission and we look forward to working with many of you on our projects this year.

Proposed Bylaws

The National Bylaws Committee has worked hard to create new AAUW Bylaws that will set forth the basic governing structure for the corporation as of July 1, 2009, in line with what the 2007 delegates envisioned. We tried to notify all membership that feedback on this proposal was accepted until August 30, 2008. They are now in the process of reviewing this feedback, to integrate the suggestions into Proposed Bylaws that will be posted in the The Outlook pre-convention issue in the spring and the website. Workshops on the final version of the Bylaws will be offered at the National Convention in June 2009, followed by voting for elements within the Bylaws.

The proposed bylaws include several bylaws that have been added for the "new AAUW" but were not part of the original vote for the reorganization of the boards – national dues collection, additional membership changes, changes to regional director status, etc. If you read these proposed bylaws, remember to open your mind and widen your vision of how these bylaws will make AAUW a viable and vital organization for all members by streamlining the bylaws, adding flexibility at all levels (states and branches also), and providing members with multiple ways to participate in AAUW.

The proposed Bylaws that were offered for review in August 2008 are summarized here.

- The restructuring that was approved at the 2007 convention necessitated these proposed Bylaws changes. Also required was further explanation of the laws governing the modification of our 501(c) 3 and 501(c) 4 structures.
- These changes are proposed; they will be discussed and voted on at the 2009 National convention.
- Any changes that do pass will be binding on each state July 1, 2009. Some changes will be mandatory, but others allow flexibility that states and branches may or may not want to implement.

MAJOR PROPOSED CHANGES:

ORGANIZATIONAL FLEXIBILITY

- Most assets will be moved to EF, a 501(c) 3, which becomes the membership organization.
- EF will be renamed American Association of University Women but will be known primarily as AAUW.
- The smaller lobbying organization (presently known as American Association of University Women) is a 501(c) 4 and is to be given a new name at the convention.
- There will be fewer National elected officers and fewer standing committees.
- States can be free to choose their branch structure, with no required positions other than an administrative and a financial contact.
- Designated regional districts will be deleted.
- The AAUW Board may appoint task forces and committees as desired and needed.
- Non-AAUW members may be appointed to committees for their expertise, so long as the majority of the committee members are AAUW members.

CONNECTION TO AND PARTICIPATION IN AAUW

- Members will pay dues directly to national AAUW, preferably online.
- A portion of the national dues will be tax-deductible.
- Anyone who supports the AAUW mission is eligible for membership.
- Every member is entitled to vote, hold office, and participate in AAUW activities.
- AAUW may create informal geographic, issue, or interest groups or networks that would exist nationally as additional ways for members to participate in AAUW.
- Virtual, online branches without geographic boundaries may be formed.
- Members may attend the Annual Meeting as well as the Convention, which may give them an additional opportunity to participate nationally.
- One member/one vote on all noticed National business. Options to vote in absentia will be developed.

Student Voices:

SAC Development Team Plans, Attendees Report NCCWSL Experience

Students within AAUW of Alabama have been hard at work in recent months; new members have been named to the Student Advisory Council Development Team (SAC-DT) and several SAC members attended the National Conference for College Women Student Leaders (NCCWSL) in Washington, DC.

Based on data gathered from SAC members attending the state convention, Ms. Gooch stated the SAC-DT recommends focusing on Financial Literacy, Sexual Health, and Personal & Professional Development in 2008-09. As for state convention programming, the SAC-DT recommends at least a half-day session dedicated to Professional Development. Under the guidance of Ms. Gooch, the SAC-DT will continue working in conjunction with other leaders of AAUW of Alabama throughout the year to strengthen communication and forge strong relationships within the state.

By attending the 2008 National Conference for College Women Student Leaders this past June, other members of AAUW of Alabama's SAC gained valuable experience in becoming a leader, both as students and women. Several of those attending recently shared their experiences of NCCWSL.

For Sarah Ragan, UA-Huntsville, attending NCCWSL provided an opportunity for her to critically analyze her personal leadership skills and address new forms of engagement with peers and fellow leaders. Interacting with colleagues from across the nation regarding leadership and women's issues further emphasized this self-examination. The same sentiments were echoed by another SAC member, Rachel Lackey, UA-Huntsville, "It was exciting to attend the workshops and brainstorm with other young women from the country working as hard as me to make positive changes in their respective communities and campuses." She added, "the discussions over the breakfast table were as informative and inspiring as the lectures and workshops afterward."

Attending NCCWSL 2008 was not a new experience for UA-Huntsville graduate student and former AAUW of Alabama Communication director Candice Rigsby Bressler; this was Candice's third time to attend NCCWSL, but this year provided a new opportunity for her to explore her own leadership capabilities. Candice was a guest presenter of a workshop entitled, "How to Create a Student Advisory Council for Your State or Branch." After returning to Huntsville, Candice was contacted by several student leaders who attended her workshop. Now Student Advisory Councils modeled after AAUW of Alabama's own SAC are being organized throughout Louisiana, Missouri, Michigan, New York, Oregon, and Texas.

All the students were appreciative of the financial support from AAUW of Alabama, branches, and members to attend NCCWSL 2008. Renea Gooch

Message from the SEC Regional Director: Note: Required IRS Filing - All Branches Must Comply

This is a historic year for AAUW. The two current boards of the Association and the Educational Foundation are meeting jointly to strategize the formation of the new AAUW single board approved at the 2007 convention in Phoenix for implementation July 2009. Please review the newest proposed bylaws, attend the 2009 national convention in St. Louis and vote on these changes.

If interested in serving on the National Assessment Governing Board (NAGB), the Secretary of Education has these openings for qualified candidates: Elementary School Principal, General Public/Parent, State Legislator (Democrat... their selection, not ours), and Testing and Measurement Expert. Info is available at www.nagb.org, or contact me (edeharo@tulane.edu) **before September 30th** to forward nominating letters and resumes to the appropriate person at AAUW.

Also, I want to remind all branch and state Treasurer's there are new rules we must abide by with respect to Internal Revenue Service filing. Before 2007, any unincorporated branch or state (most of us) was not required to file a tax return with the IRS if the total assets were less than \$25,000 (definitely most of us!). This changed in 2007 and now those branches and states (and regions) are required to file a 990N electronic postcard. The 2007 filing is due the 15th of the fifth month after the end of the fiscal year; unless your bylaws state otherwise, the fiscal year ends June 30th (corresponds with the membership year) which means that the 990N postcard must be filed by November 15th! If your Treasurer has not done so already, I would NOT recommend waiting until the last minute!

All branches, states, and regions had an opportunity to join AAUW's Group Exemption with the IRS; do not confuse this with the requirement to file the 990N postcard OR the fact that all AAUW entities MUST have their own Employer Identification Number (EIN#) which is assigned, upon request, by the IRS. I sincerely hope that NO branch or state is still using the national EIN#. To investigate the status of your EIN#, contact the Internal Revenue Service Business and Specialty Tax line at 1-800-829-4933 (7 am – 10 pm) or on line at www.irs.gov. The agents can do a search on your EIN# and take your application for one by phone, if necessary. Online applications take 6-8 weeks but phone applications are immediate.

To file the 990N postcard go to the IRS website (www. irs.gov) and click on the link. You will need to provide the organization's name, the contact name and address (usually the Treasurer), the EIN#, your website name (if applicable), your end of fiscal year date and finally... to state that assets are less than \$25,000. If you have not seen the 2008 Leadership DVD Module on Financial Accountability (#7), you can view the slides as a pdf file at https://www.aauw.org/member_center/branches_states/leadershipDev/loader.cfm?url=/common-spot/security/getfile.cfm&PageID=24759; this information is valuable to anyone who is a Treasurer for other organizations

as well! All branch officers should view this information.

If anyone has problems filing the 990N electronic postcard for an AAUW entity, contact AAUW Finance Vice President Linda Bors at linda.bors@cox.net. I had a problem with another organization, but Linda feels that AAUW branches who have signed onto AAUW's Group Exemption will not experience problems. If you have experienced problems in filing, please also contact me at edeharo@tulane.edu. Just an additional note... the IRS purged some EIN#s; if you get an error message in red, call the number provided so that the problem can be researched and you can even file by phone. The National AAUW office is NOT filing for any branch, state, or region; it is the responsibility of the Treasurer of that entity!
