<u>President's Message</u>



Several years ago, as membership vice president of my branch, I found myself contemplating how I would present AAUW as an organization that is worth join-

ing. I know I joined because I wanted to meet intelligent women who were working on important issues that make a difference in people's lives. And since then, I have befriended many such women in my branch and throughout the state.

But AAUW is more that just a group of wonderful women working together on local issues. AAUW is a national organization that brings together women from across our country to tackle important issues that impact women and girls in all stages of our lives.

Our individual concern for the needs of women and girls is manifested in the **AAUW Public Policy Program**. It builds upon more than 125 years of responsible public participation and our principles provide the basis for AAUW members' actions at the local, state, and national levels. AAUW members can have a voice in the next version of Public Policy principles as they had the opportunity to provide input for them earlier this fall.

Of course, those of you who wish to be more personally involved in these issues on a local level can work as a state officer, on one of our state programs, or on a special program promoted by your local branch.

Statewide, we have the following activities for you to work on:

- Support the Ready to Run^{TM} program to train women on how to run for public office.

- Lend your efforts to promote pay equity and establish an Equal Pay Commission in Alabama.

- Support the Alabama Citizens for Constitutional Reform and Alabama Arise.

- Promote student leadership through the Alabama Student Advisory Council.

- Help establish programs throughout the state to educate young girls about careers in science and technology.

- Help establish a College/ University relations committee to promote AAUW related activities and fellowships on college campuses in our state.

- Participate as an active member of the State Board of Directors.

So why be involved with AAUW? If even just one of the AAUW priorities is an important issue for you, you now have an opportunity to take action. With AAUW, you can pick your passion from the many issues that we support, and do something to make a difference. If we don't have a local or state program that interests you, then you can help us start one. AAUW needs active, passionate women to move ahead. AAUW needs YOU. Branch News

Huntsville

The Huntsville AAUW branch hosted a cluster meeting of other North Alabama branches on Saturday, November 6. The main topic for presentation and discussion were the issues presented in the book "The Shriver Report: A Woman's Nation Changes Everything," compiled by Maria Shriver.



AAUW's mission to promote "equity for women and girls through advocacy, education, philanthropy, and research" is clearly advanced through the Shriver Report. AAUW of Alabama President Jo Ann Cummings addressed some of the key policy issues arising from the Shriver Report. A related issue is pay equity for women. Alabama Arise reports that "on average, Alabama women earn 72 cents for every dollar earned by men," and with more women as primary breadwinners, "shortchanging women hurts families, too."

Anna Blair, Public Policy chair for AAUW of Alabama, discussed these pay equity issues and the argument for making the Alabama Equal Pay Commission permanent in order to close the pay gap. Shriver's findings were first published as *A Woman's Nation Changes Everything*, and a newly updated edition was released October 15 (the 2009 edition is available online at http://www.shriverreport.com/awn/).

Montevallo

For the coming year, the theme for the Montevallo Branch of AAUW will be "Making a World of Difference through Advocacy, Education and Research." This year's programs offer opportunities for learning more about ideas and issues that affect women and their families. and for working with others to promote equity, research, and lifelong learning. Our program included a session on October 20 on Issues in Literature for Children and Young Adults, a December 2nd program by Montevallo Professor Daniel Deffenbaugh on the Intersection on Faith and Ecology, and a holiday dinner and bazaar to benefit AAUW's Legal Advocacy Fund. On January 27 we will focus on educational opportunities for nontraditional students, featuring a presentation by UM graduate and attorney, Ahrian Davis, who directs the prestigious Smith Scholarship Program. On February 24, we plan a community-wide Black History/Women's History Month event with a Reader's Theater presentation of Pearl Cleage's poem "We Call Their Names" and a discussion of Women of Uncommon Valor by Dr. Geraldine Bell and Dr. Hattie Griffin Lamar. On March 24 we will have a style show, luncheon and silent auction to raise money for AAUW's Educational Funds and Reading Is Fundamental. On April 28, Kelly Wacker will coordinate a program on Sustainability Projects such as Community Gardens and Farmers Markets.

We continue the Adelante! Book Group in which we review and discuss books of special interest to women and their families. The Adelante! Book Group sessions started September 29 with a discussion of Elizabeth Gilbert's Eat, Prav, Love and Committed (9/29; 4:00 p.m. Hill House). Reviewers for this first session were Mary Lou Williams and Michele Hill. Book group participants also enjoyed a discussion by Montevallo Professor Daniel Deffenbaugh of The Last Child in the Woods by Richard Louv (on November 10). On December 8, reviewers Becky Cox Rodgers and Cheryl Patton led a discussion of Tracy Chevalier's Remarkable Creatures and Georgina Howell's Gertrude Bell, two books

about prominent 19th century women in science.

Decatur

On December 10-11, the AAUW Decatur Branch held its Holiday Used Book Sale at the Decatur Mall. The net proceeds from this sale will be used to fund scholarships for women to attend Calhoun Community College.

Auburn

AAUW Funds Demystified By Amanda Melcher, AAUW Funds Vice President

As AAUW begins a new year, please remember that your donations allow AAUW to deliver programs that support the equality of women and girls. There are several ways to give to AAUW that are tax deductible as a charitable gift on your personal federal tax return. Unrestricted gifts to AAUW Funds (#9110) are the most useful way to help women and girls break through educational and economic barriers. You make it possible to respond to the most urgent needs and to take advantage of the best opportunities so that all women and girls have a fair chance.

The Educational Opportunities

Fund (#4336) supports educational and lifelong learning opportunities. Some of our programs include: Fellowships and Grants, which has hundreds of endowed fund numbers. each for a specific fellowship, career development grant, community action grant, or selected professions award; The Fellows Alumnae Initiative, which inspires women by providing access to the network of past and current AAUW fellows and grantees; and The Undergraduate Scholarship *Clearinghouse*, which educates women by allowing students to find and apply for much-needed scholarships from AAUW branches across the country.

The Eleanor Roosevelt Fund

(#9170) supports AAUW research to provide analysis, data, and accurate information about issues that are important to women and girls. This includes reports such as the *Pay Equity Gap* and *Why So Few Women in Science, Technology, Engineering and Math.*

The Legal Advocacy Fund (#3999) supports the protection of the legal rights of those who are facing discrimination. Some of LAF's programs include: *Legal Case Support*, which protects LAF plaintiffs by supporting workplace sex discrimination cases; *LAF Case Support Travel Grants*, which protect AAUW members through educational programs about legal rights delivered by LAF plaintiffs and lawyers; and *Campus Outreach Projects*, which protect college students from discrimination, harassment, and assault through on-campus program grants.

The Leadership Programs Fund

(#4339) supports programs that develop women's potential to lead in their schools, communities, and country. Leadership programs include:

- The National Conference for College Women Student Leaders: Develop leadership skills, networks, and ambition at this three-day conference held annually in Washington, D.C.

- Campus Action Projects: AAUW awards grants to campus leaders to deliver programs guided by the findings of AAUW research to address a genderbased issue in their community.

- Elect Her: Teaches leaders the skills needed to run for student government and successfully increases the number of women who are involved in making decisions that affect all students on campus. These student leaders are also introduced to a national network of women who are running for and holding public offices.

The Public Policy Fund (#4337) supports advocacy for public policies and laws that are fair to women. Public policy programs include: *Government Relations*, in which AAUW advocates on Capitol Hill and in the White House, ensuring that our voices are heard; *Civic Engagement*, with information and tools to build robust woman-to-woman voter registration and turnout drives in their communities; and *Field Organizing*, which engages individuals and branches in public policy advocacy.

The only contributions not eligible for a tax deduction as a charitable gift are those to the AAUW Action Fund, which operates our Lobby Corps and voter education activities. To make a gift to support these activities, you should

make your check payable to **AAUW** Action Fund.

AAUW of Alabama Wins National Awards for AAUW Funds

I am proud to announce that AAUW of Alabama has received four awards that recognize our achievement in fundraising in 2009. We did not receive these awards until midsummer 2010.

The AAUW Eleanor Roosevelt Fund, established in 1988, supports groundbreaking research on the educational experiences of women and girls, Teacher Fellowships, and an annual Teacher Institute. AAUW of Alabama has been awarded **Second Place** for **State Per Capita** giving for our contributions to the **Eleanor Roosevelt Fund**.

The AAUW Legal Advocacy Fund works to combat sex discrimination in higher education and the workplace, providing support to workplace sex discrimination cases that have the potential to make a difference for all women. AAUW of Alabama has achieved **Eighth Place** for **State Per Capita** giving for our contributions to the **Legal Advocacy Fund**.

The AAUW Leadership Programs Fund supports the Campus Action Projects, the National Student Advisory Council, Elect Her, the \$mart \$tart Salary Negotiation Workshop and the National Conference for College Women Student Leaders (NCCWSL). We received **Fifth Place** for **Total State** giving and **Second Place** for **State Per Capita** giving for our contributions to the Leadership Programs Fund.

AAUW of Alabama Ready to Run[™]



Currently, women hold just 17 percent of the seats in Congress and 24 percent of the seats in state legislatures. In Alabama, we have no women serving in Congress and only 12.9 percent of our state legislators are women. Ready to RunTM, sponsored by AAUW of Alabama, is a nonpartisan program that trains women who want to run for office, seek higher office, or work on a campaign.

Montgomery -- AAUW Montgomery sponsored its first Annual Ready to Run[™] Training on July 24, 2010, at the Capitol Hill Robert Trent Jones Golf Trail clubhouse in Prattville, Alabama. Ten women, ages 16 to 60, participated in the training. Wanda Foster, State Program vice president and co-director of Ready to Run[™], attended to lend her support.

The keynote speaker was The Honorable Sharon Yates, of the 15th Judicial Circuit Court. Judge Yates shared her experiences in campaigning for public office. She is the first woman to serve on the Alabama Court of Civil Appeals and was the presiding judge from 2001 to 2005.

Jill Nolin of the *Montgomery Advertiser* gave a humorous presentation on how to handle the media during political campaigns. Other trainers included AAUW's own Susan Sheppard, co-director of Ready to RunTM; Anna Blair; Audrey Salgado; and Janet Smith. The Ready to Run[™] team regretfully announces that they had to cancel the workshops scheduled for Birmingham (October 16) and Huntsville (October 23) because of low registration, though interest has been high. We've discovered that October in an election year is a bad time to schedule a workshop. We will reschedule sometime in 2011 and keep you informed. Elect Her — Campus Women Win is a collaboration between the American Association of University Women and Running Start. Next year, it will be held on 20 campuses around the nation, including the University of Alabama, Tuscaloosa. The program, which aims to encourage more young women to run for office, will return to its nine original program sites and will debut at 11 new campuses in 2011. Elect Her — Campus Women Win is such a vital program because it engages a whole new generation of college women in the pursuit of running for student body leadership positions. Many of these students have never considered running for office before, but Elect Her challenges them to change the statistics that show men dominating student governments. The experience these women gain is the very best training for running for office later in life.

ACCR- Fourth Annual Bailey Thomson Awards Luncheon

On August 19th in Tuscaloosa's Bryant Conference Center, almost 400 supporters gathered to celebrate the 10th anniversary of the Alabama Citizens for Constitutional Reform and the Fourth Annual Bailey Thomson Awards Luncheon. The keynote speaker was Dr. David Mathews, former University of Alabama president. He currently serves as President and CEO of the not-for-profit research organization, the Kettering Foundation. He also served as the Secretary for Health, Education, and Welfare in the Ford Administration. He traced the progress made in the constitutional reform movement over the last 15-20 years.

The four awards given at this year's luncheon are:

Edgar C. Gentle III: Bailey Thomson Award

A Birmingham attorney and Rhodes Scholar, Mr. Gentle is an active proponent of constitutional reform who takes his message around the state, educating Alabama citizens about the urgent need to build a modern frame-work that will enable our state to reach its full potential.

Melanie Jeffcoat:

Educator of the Year An experienced filmmaker, Ms. Jeffcoat researched and co-produced <u>Open Secret</u>, an award-winning documentary that persuasively advocates for reform of the 1901 Alabama Constitution. The film has been screened to enthusiastic audiences statewide since its premiere in February, and was shown at our state convention in April 2010.

Hill Carmichael and Mark Berte (AAUW member): ACCR Foundation Spirit Award

Committed supporters of constitutional reform, Hill Carmichael and Mark Berte have been at the forefront of grassroots efforts for many years. Influential and articulate, they are credited with developing and implementing creative strategies to build public support for a new constitution.

Community Foundation of Greater Birmingham: Partner of the Year A vital ACCR funding partner, the Community Foundation of Greater

Birmingham helped underwrite the mock constitution convention as well as the Bring It Back Home grassroots education project. The Foundation's generous support is integral to growth of reform efforts.

Equal Pay Commission and Alabama Arise

On September 18th, Alabama Arise held its annual meeting in Montgomery to determine the legislative priorities that it will pursue in 2011. In addition to the recurring topics of adequate state budgets and tax reform, members voted on five other topics to focus on in 2011.

AAUW of Alabama proposed that Arise support a bill to establish an Equal Pay Commission for Alabama, which we have lobbied for the last five years. Jo Ann Cummings made the presentation to the group. All AAUW branches who are members of Arise were represented at the meeting when the votes were cast, and the Equal Pay Commission was accepted as a 2011 priority.





After November 2nd, when our next group of Alabama representatives and senators are elected, we will begin our planning to gather co-sponsors and supporters for the bill that will be presented in 2011. All Alabama members are requested to help us to lobby for passage of this bill.

The other issues for 2011 that were adopted are: constitutional reform, public transportation, worker savings incentives and the death penalty moratorium.

AAUW of Alabama History Project

AAUW of Alabama has been around for many years. It was organized as a state organization in 1927, but several branches were established before that date. Montgomery and Birmingham were both established in 1921. So far, the history of our state organization has been documented in two volumes. The first book, *A Half Century of AAUW in Alabama*, covers the years 1927-1977. The second book covers the fifteen years 1976-1991. Now, the time has come to update our history from 1991 to 2011.

We are establishing a History Project to help us preserve the history of our state and branch organizations. The History Project will be composed of three parts: a) research and documentation of the history 1991-2011; b) digitalization of the existing two books; and c) production of a complete-to-date history, combining the original information with the "new" information.

Each branch will need to examine their records to develop a year-by-year summary that highlights the activities and accomplishments of their branch, and the state will have to do the same. Officers and branch historians from the last 15-20 years may be able to help to compile this data.

We are researching a way to scan in the earlier documents to have them transcribed into an electronic format. Then we will have a way to preserve the complete history of our state and branches before all of the details are forgotten. This project will probably take at least a year, and we will target the document release for the 2012 state convention. If you are interested in helping with this project, contact Wanda Foster

One Member, One Vote

Adopted at the 2009 AAUW National Convention, the concept of **One Member, One Vote** moved AAUW national elections beyond a delegateonly process to an every-member opportunity. Under **One Member, One Vote**, members can now propose and discuss bylaw changes, resolutions, and Public Policy Program amendments online and "meet" the candidates through biographies, video, and candidate links.

In addition to frequent website and other online updates, key information will be available to all members in the Fall, Winter, and Spring/Summer issues of *AAUW Outlook* as well.

Please log in, explore the **One Member**, **One Vote** online system, and familiarize yourself with the process. A <u>Frequently Asked Questions</u> document (FAQ) is available to assist you. To access the online system from the AAUW home page, click on Member Center (in the top right corner), log in with your member ID, and then select **One Member, One Vote**.
